## Introduction

In 1938, three Asian families, descendants of three Chinese emperors, deposited their private savings, which they had accumulated as businessmen by exporting jade, porcelain, clothes and carpets made of silk and tea, in the USA to protect them from the attacking Japanese. These savings are the best out of six (possibly 7) steamship cargoes full of gold bars, which have been duly declared, unloaded by the Port authority of New York and received by officials of the FED against the delivery of official documents – gold-backed bonds in paper form. The term was 60 years. The repayment date was in 1998.

And in fact, the investigators found all the unloading documents of the port authority as well as the handover documents to the FED. The court had the signatures of court-certified graphologists (handwriting scientists) compared.

After checking the signatures, these graphologists submitted an official scientific report, in which they recognized not only the documents as genuine on the basis of detailed recognition of details, stating the type and quality of the paper, including the year of manufacture, but also the original signatures attached to them; these were not only genuine, but also identical to the power of attorney signatures deposited by the port authority in the commercial Register.

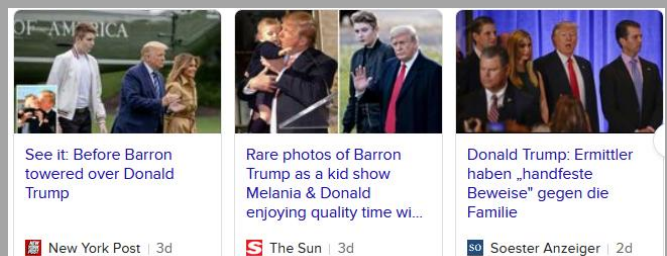

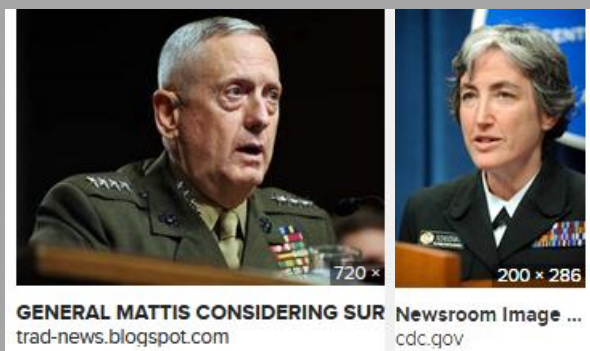

### What is quantum financial system (QFS) Blockchain?

The goal of the **Quantum Financial System** is to promote the growth of every single country, including third world countries by improving the current financial **system**. The **system** that we have today tends to create a debt crisis, where high interest rates lead to growing difficulties in repaying debt.

Innovations in the transition from the Rothschild system to the **QFS Quantum Finance System**, as the CIPS is now called, are as follows: the US dollar (privately owned by the Rothschilds since 1914) - including the petro dollar - is abolished, the FED and the CIA are abolished, as is the Rothschild-owned IMF.

The previous central banking system controlled by the Rothschilds, headed by the BIS – the Rothschild Bank for International Settlements in Basel – will be decommissioned, as will the Red shield (Rothschild) payment system SWIFT. This reverses the privatization of state-owned central banks, which had been underway in the Netherlands since about 1660. Every country regains its own independancy, becomes its own again. The currencies of the individual countries return to their own governments; the respective treasury (Ministry of Finance) of the individual now independent nation is responsible for this.

The national currencies are gold backed, but not directly linked, so that the gold price can no longer be manipulated by large-scale conducted currency manipulations of individual persons or entire clans using self-printed worthless Rothschild paper money, as it has been up to now. The downward speculation of the individual national currencies through short sales of foreign mega speculators by means of self-printed Rothschild paper money is thus made impossible. The individual national currencies are defined in such a way that an exchange ratio (exchange rate) of 1:1 is given at the beginning.

Iran, with the support of Russia and China, is taking over security in the Middle East. At the southern entrance to the Red Sea, China already has a military garrison specially designed as an anti-terrorist defense system and has already leased three ports in the Mediterranean, two of which are in Israel. This is intended to motivate NATO warships to withdraw from the eastern Mediterranean.

## The details of the GENERAL Agreement

### NESARA / GESARA Global Economic Security and Reformation
